

No one is getting a 13% raise. The raises were 4% for all bargaining units across the board and this is a negotiated process that cannot be changed. Board President Steven Patch stated he will not support cuts in BOCES programs and Board member Allison Douglas agreed. He also stated that he did write to the Governor and Assemblyman Barclay regarding the Board's displeasure at the 2% that our District received.
