# Central Square varsity girls flag football is off and running

What began with a small but determined core group of student-athletes quickly grew into a full-fledged team, now boasting 35 passionate and dedicated players.



"All of us at CSSD are so proud of all of the high school girls that got the word out and recruited so that our inaugural flag football season can happen this year," said Central Square Superintendent Thomas J. Colabufo. "These are amazingly talented young ladies that have shined on the gridiron this spring."

The team's formation marks a milestone for the district, thanks in part to the leadership of Athletic Director Jamie Grimshaw, who was praised by Colabufo for his "excellent" efforts in bringing the program to life this spring.

With each practice and game, the team is blazing a trail not just for themselves, but for future generations of Redhawk athletes. Their teamwork, energy and commitment to the game have already left a lasting mark on the Central Square community.

# A Letter from the Superintendent

#### Dear Parents/Guardians/CSSD Community:

Each year, I'm proud to share the tremendous progress and accomplishments of our school district. Thanks to your continued support and investment, Central Square continues to grow as a model of academic excellence, opportunity, and student engagement.

At Paul V. Moore High School, we offer 26 college-level dual credit courses through Cayuga Community College, SUNY Oswego, Syracuse University, and advanced placement programs in art, business, world language, English, science, social studies, math, and technology. What makes this even more remarkable is that our District covers 100% of the college tuition costs, ensuring every student, regardless of financial circumstance, can earn college credit. Parents of recent graduates have shared that this has saved their families between \$40,000-\$65,000 — a life-changing benefit that levels the playing field and opens doors for all.

We've also expanded access to more than a dozen distance learning courses, taught by college professors or instructors across New York State. These unique opportunities ensure that every student can pursue their passions, whether in STEM, the arts, business, or trades. With comprehensive course offerings in every academic area — including 18 art, 14 business, 14 science, 13 social studies, 12 math, 12 technology, 11 ELA, 10 world language and more — our high school provides something meaningful for every learner.

Our Fine Arts program continues to earn state and national recognition, with hundreds of students participating in musical theater, jazz ensembles, marching band, color guard, drumline,

and drama. These programs not only foster talent, but also confidence, collaboration and creativity.

In both middle and high school, students are actively engaged in nearly 50 clubs and extracurriculars, serving hundreds daily after school. Our athletic program is thriving, with more than 1,200 student-athlete participants this year alone across modified, JV and varsity teams.

Academically, our students continue to shine:

- Our graduation rate reached 90% last year.
- The number of students with disabilities earning Regents diplomas rose significantly to 73%.
- Elementary math and reading scores continue to improve year after year.
- Our districtwide attendance rate is at 92%, a powerful reflection of student engagement and support.

At Central Square, we believe in meeting students where they are — not forcing them into a one-size-fits-all model. Whether students are headed for college, the workforce, or the military, they can begin building their unique path as early as middle school.

None of this would be possible without you. Your support has built a District where every student — all 3,600 of them — can thrive. On behalf of our faculty, staff, and administration, thank you for investing in our students' futures.


# THREE OPEN BOARD MEMBER SEATS (three 3-year terms)



# **Wall of Distinction**


Two Paul V. Moore High School alumni joined the ranks of the Central Square School District's Wall of Distinction during a mid-April ceremony.

# What will I be voting for on May 20th?

Polls will be open on May 20, 2025 from 8 a.m. to 9 p.m. Voters will decide on the following items:

# **PROPOSITION 1**2025-2026 GENERAL FUND BUDGET

Shall the Board of Education of the Central Square Central School District, County of Oswego, State of New York, be authorized to incur expenditures not exceeding \$103,896,223 (U.S. Dollars: One Hundred and Three Million, Eight Hundred and Ninety-Six Thousand, and Two Hundred and Twenty-Three) or so much as necessary for its General Fund operating expenses during the school fiscal year beginning July 1, 2025 and ending June 30, 2026, and to levy a tax on the taxable property of the School District sufficient to meet the amount of this sum not received from other sources?

# **PROPOSITION 2**SCHOOL TRANSPORTATION VEHICLES

Shall the Board of Education of the Central Square Central School District be authorized to purchase and finance seven (7) diesel/gas, 65-passenger student transportation vehicles, two (2) diesel/gas, 30-passenger student transportation vehicles, and one (1) diesel/gas, 24-passenger/5 wheelchair student transportation vehicle, including necessary furnishings, fixtures and equipment and all other costs incidental thereto, and expend a total sum not to exceed \$1,769,100, which is estimated to be the total maximum cost thereof, and said amount, or so much thereof as may be necessary, shall be raised by the levy of a tax upon the taxable property of said School District and collected in annual installments as provided by Section 416 of the Education Law; and, in anticipation of such tax, obligations of said School District, in the principal amount not to exceed \$1,769,100, shall be issued.

# **PROPOSITION 3**LIBRARY TAX

That the Board of Education of the Central Square Central School District, County of Oswego, State of New York, pursuant to Education Law, Section 295, be authorized to levy and collect an annual tax, year after year, separate and apart from the annual school district budget, in the amount of \$25,000 (in addition to the current annual appropriation of \$70,000 for a total of \$95,000 annually), which shall be paid to the Central Square Library for the support and maintenance of the library, with this appropriated amount to be the annual appropriation until thereafter modified by a future vote of the electors of the Central Square Central School District.

# Board Approves Resolution for a Capital Outlay Project at the March 10, 2025 Meeting

Under current SED law for projects that are wholly funded through budgeted capital outlay which have a total cost of no more than \$100,000, these costs are reimbursed through building aid.

Central Square School District's budget proposal includes a \$100,000 Capital Outlay Project (found in the debt service category). This includes replacement of dust collectors and carpet replacement at the CS Middle School, including, site improvements, original furnishings, fixtures and equipment.

## WHO CAN VOTE?

# According to New York State Education Law, in order to vote, you must be:

- 18 years of age
- A resident of the district for at least 30 days prior to vote
- · A citizen of the United States
- A registered voter\*
- \* You may register with the school District Clerk up to five (5) days prior to the annual election or with Oswego County Board of Elections up to ten (10) days prior to the election. The District Clerk, Pearl Horn, will conduct voter registration at the District Office Monday through Friday between the hours of 8 a.m. and 4 p.m. Personal identification and proof of residency must be provided at the time of registration.

# Three-Part Budget

All school districts are required by law to present their budgets in three component parts; program, administrative and capital. The program component represents the largest portion of the District's budget. Program costs include the salaries and benefits of all teachers and staff delivering pupil services.


